- iii. Valid means of identification (National ID, Drivers License, International Passport Data Page) for individuals and Directors of Corporate entities;
- iv. Proof of financial capability and source of funding;

BIDDING PROCEDURE:

- i. The sale process shall be through an open competitive bidding process;
- ii. The properties shall be sold "as is" and "where is;"
